IMPORTANT: THE FOLLOWING RULES AND REGULATIONS FOR BLOCK PARTIES ARE STRICTLY ENFORCED. FAILURE TO COMPLY MAY RESULT IN DENIAL OF FUTURE REQUESTS:

1. To be held on date requested, 9:00 AM to 11 PM
2. Barricades, when available, will be provided by the Village, and shall be erected at both ends of the street before the block party starts. Also, the Fire Dept. would appreciate if tables and chairs be placed on the side of the street which is opposite from the fire hydrants.
3. All garbage and debris is to be cleaned up by the applicants.
4. Fireworks are prohibited.
5. Applicants must comply with all Village Ordinances (SEE ATTACHED).
6. FILE APPLICATION TWO WEEKS PRIOR TO BLOCK PARTY OR WILL NOT BE ACCEPTED.
7. VEHICLES MAY NOT BE USED TO BLOCK INTERSECTION.

A CONDITION OF THIS PERMIT IS THAT THE VILLAGE ASSUMES NO RESPONSIBIITY FOR ANY AND ALL LIABILITY THAT MAY OCCUR.

SIGNATURE SHEET OF HOMEOWNERS MUST BE ATTACHED TO THIS REQUEST FORM.

ALL RESIDENTS ON THE BLOCK MUST BE NOTIFED OF THE DATE OF THE PARTY EVEN IF THEY ARE NOT PARTICIPATING.

Village Ordinances

Please keep for your records

§ 70-2. RESTRICTIONS.

NO PERSON SHALL DRINK OR CONSUME AN ALCOHOLIC BEVERAGE OR POSSESS, WITH INTENT TO DRINK OR CONSUME, AN OPEN CONTAINER CONTAINING AN ALCOHOLIC BEVERAGE OR WITH THE INTENT TO CONSUME SAID ALCOHOLIC BEVERAGE IN ANY PUBLIC PLACE OR TO HAVE THE SAME SO CONSUMED BY ANOTHER, EXCEPT AT A BLOCK PARTY, FEAST OR SIMILAR FUNCTION FOR WHICH A PERMIT OR WRITTEN CONSENT HAS BEEN OBTAINED FROM THE INCORPORATED VILLAGE OF MASSAPEQUA PARK.

§ 218-1. GENERAL PROHIBITION.

IT SHALL BE UNLAWFUL FOR ANY PERSON TO MAKE, CONTINUE OR CAUSE TO BE MADE OR CONTINUED ANY LOUD, UNNECESSARY OR UNUSUAL NOISE OR ANY NOISE WHICH ANNOYS, DISTURBS OR INJURES OR ENDANGERS THE COMFORT, REPOSE, HEALTH, PEACE OR SAFETY OF OTHERS. THE RESTRICTIONS ENUMERATED IN THIS CHAPTER ARE SPECIFIC ENACTMENTS TO CURB AND PREVENT DISTURBING AND UNNECESSARY NOISES IN VIOLATION OF THIS CHAPTER, BUT SAID ENUMERATION SHALL NOT BE DEEMED TO BE EXCLUSIVE.

§ 218-3. LOUDSPEAKERS AND OTHER SOUND-AMPLIFYING DEVICES.

NO PERSON SHALL MAINTAIN OR OPERATE OR PERMIT TO BE MAINTAINED OR OPERATED ANY LOUDSPEAKER ATTACHMENT CONNECTED WITH A RADIO OR TELEVISION APPARATUS OR TALKING MACHINE OR OTHER PRIMARY SOURCE OF SOUND IN SUCH MANNER THAT THE LOUDSPEAKER WILL PROJECT SOUND OUTSIDE OF ANY BUILDING SO THAT THE SOUND IS AUDIBLE FOR A DISTANCE OF MORE THAN 30 FEET FROM THE POINT OF ITS ORIGIN.

§ 322-22.1. BLOCKING ACCESS TO PUBLIC STREETS PROHIBITED.

NO PERSON, ENTITY, PARTNERSHIP OR CORPORATION SHALL BE ALLOWED TO PARK, PLACE, STAND OR STOP ANY MOTOR VEHICLE ON ANY STREET IN THE VILLAGE OF MASSAPEQUA PARK OR ON ANY OTHER VILLAGE PROPERTY WHICH BLOCKS OR OBSTRUCTS ACCESS TO AN ENTRANCE OR EXIT OF ANY STREET.
