**NOTICE TO BIDDERS**

**ADVERTISEMENT FOR BIDS**

**A-1** Sealed bids for the “ROOF PROJECT AT VILLAGE HALL AND BRADY PARK COMMUNITY CENTER”, in Massapequa Park, will be received by the Board of Trustees of the Village of Massapequa Park, at the office of the Village Administrator in the Village Hall until March 23, 2023, 11:00 AM at which time they will be publicly opened and be read aloud.

**A-2** The Information for Bidders, Price Schedule, Form of Bid, Form of Contract, Plans, Specification and Form of Bid Bond may be examined at the said office, and copies thereof may be obtained at the office of the Village Administrator in the Village Hall.

**A-3** Each bidder must deposit with his bid, security in an amount not less than five percent (5%) of his bid, in the form and subject to the conditions provided in the Information of Bidders.

**A-4** Any bidder may withdraw his bid, either personally or by written request (if such request is received by the Board of Trustees at any time prior to one minute before the scheduled closing time for receipt bids). If a contract is not awarded within 45 days after opening of the bids, all bidders may withdraw their proposals by written notice.

**A-5** The Village, through its Board of Trustees, reserves the right to waive any informalities in, to reject any or all bids and to accept that bid which it deems most favorable to the Village.

**A-6** Attention of bidders is particularly called to the requirements as to conditions of employment to be observed and the minimum wage rates to be paid under the contract.

The bid documents will be available at the above office between the hours of 9:00 a.m. and 4:30 p.m., Saturdays and Sundays excluded, on or after March 2, 2023.

A “walk-thru” inspection of the site and area of construction will be conducted by the Owner at 9 AM, local time on March 8, 2023. The inspection will start at the Brady Park Community Center, Lake Shore Drive, Massapequa Park, NY and finish at Village Hall, 151 Front Street, Massapequa Park, NY. Prospective bidders attendance at the “walk-thru” inspection is not mandatory.
