1. PERMITS ARE VALID FROM JUNE 1, 2023 THROUGH MAY 31, 2024.
2. PERMITS ARE ISSUED FOR PERSONS EMPLOYED IN STORES OR OFFICES IN THE VILLAGE AND BECOME VOID WHEN EMPLOYMENT ENDS.
3. PERMITS ARE TO BE ISSUED FOR PARKING IN EMPLOYEE PARKING AREAS ONLY DURING THE HOURS OF EMPLOYMENT IN THE VILLAGE. STICKER MUST BE PLACED ON REAR BUMPER, DRIVER SIDE OR TICKETS WILL BE ISSUED.
4. THE VILLAGE WILL REQUEST A LETTER OF EMPLOYMENT SIGNED FROM THE EMPLOYER AND A COPY OF REGISTRATION.
5. ALL PERMITS ARE ISSUED TO THE VEHICLE DESCRIBED ABOVE AND MAY NOT BE TRANSFERRED TO ANOTHER VEHICLE OR INDIVIDUAL NOT NAMED ABOVE.
6. IT SHALL BE UNLAWFUL AND A VIOLATION FOR ANY PERSON TO OBTAIN UNDER FALSE PRETENSE OR MAKE FALSE, FRAUDULENT OR INACCURATE STATEMENTS IN ANY APPLICATION TO OBTAIN SAID PARKING PERMIT OR USE SAID PARKING PERMIT IN AN UNAUTHORIZED OR ILLEGAL MANNER.
7. ANY PERSON VIOLATING PERMIT REGISTRATION SHALL HAVE HIS OR HER PARKING PERMIT REVOKED FOR ONE FULL YEAR AND THAT PERSON SHALL BE INELIGIBLE TO MAKE APPLICATION FOR A PARKING PERMIT FOR AN ADDITIONAL PERIOD OF TWO YEARS THEREAFTER; AND SUCH PERSON OR PERSONS SHALL BE LIABLE FOR A FINE UP TO \$250.00 FOR EVERY VIOLATION OF THIS LOCAL LAW.
